- To register, a non-refundable deposit of \$250 must accompany each application. (Make check payable to "Clara Barton Center for Children.") This deposit will be applied to summer camp tuition, and is returned only if no space is available.
- Priority for enrollment will be given to children currently enrolled at CBCC only until February 3, 2017.
- Clara Barton Summer Camp reserves the right to cancel any class for lack of enrollments. In this event, tuition paid will be refunded.
- Withdrawals must be submitted in writing by April 1, 2017 in order to receive a refund of tuition paid, less the \$250 non-refundable deposit. There will be no refunds of tuition made after March 31, 2017.
- A bill for summer camp tuition will be e-mailed on or about February 15, 2017.
- By February 24, 2017, 50% of the total summer camp tuition must be paid or your child's space may be forfeited.
- The balance of summer camp tuition is due on May 12, 2017.
- You may enroll your child for only 1 week of Sessions 2-5 for an additional surcharge of \$50 per session, but your child must be enrolled in at least one other full session and priority is given to those enrolling in a full session.
- Campers in the Summer Cardinal and Summer Eagle classes (older 4's & 5's) attend 5 days per week.
- Campers in the Summer Toucan (2's), Summer Hummingbird (young 3's), and Summer Puffin (older 3's & young 4's) classes can attend 3, 4 or 5 days per week.
- A child must be at least two years old by May 31, 2017 in order to attend summer camp.
- The majority of our regular classroom teachers take their vacations during the summer months, so your child may not have the teacher who teaches in a particular classroom during the school year as his or her summer camp teacher. Also, although we strive to maintain teaching team consistency throughout the summer for each class group, your child may not have the same teachers for each session. **(over)**
